EXHIBITOR AGREEMENT

I understand that I assume all risks for loss, theft, damage, liability, injury, cost or expense that I may incur during the 2017 Fall Fest, and further agree that I will save, defend, and hold harmless SLO Jazz Festival, Inc., and the City of Morro Bay, the City of Paso Robles, the City of San Luis Obispo, Giovanni’s Fish Market, STAX, Pavilion on the Lake, Park Place/Acorn Event Management, the City of Atascadero, and their directors, officials, volunteers, employees, and agents from any claims, loss, liability, damage, or cause of action, including attorneys’ fees, that I may incur, suffer, or be required to pay in the course of my participation as an exhibitor in the Festival. I further assume full responsibility for the safety and insurance of my own exhibit, for all sales tax occasioned by its use, and for picking up any and all trash in the area assigned to me, including both festival grounds and/or any parking facility.

I further understand and agree to the following rules (place check/read each rule:

- To conspicuously display a copy of my seller’s permit at my exhibit space (if I am not offering for a sale anything that is subject to sales tax, I will provide the Festival with a written statement to that effect, along with my driver’s license number.)
- To only exhibit products or services suitable for a family-oriented event
- To park in the designated parking area assigned to me and to conform to all entry and exit traffic patterns during all event days.
- To NOT allow PETS, audio equipment, or alcoholic beverages within or around my assigned space.
- To not exceed my assigned space size (10’ x 10’ for all vendors at Fall Fest).
- To keep my booth operational and fully set-up until either the Fall Festival Vendor Coordinator or Executive Director approves tear down.
- To not infringe on walkways, neighbor booth spaces, or move to another location without Exec Dir approval.
- I promise to maintain my own vehicle, employee, and business insurance.
- I have read the attached Exhibitor Information and agree to follow the rules there in.

I also understand that refunds will not be granted after September 23rd, 2017 (Morro Bay) or October 30, 2017 (Atascadero), and that entry fees are non-transferable without written Festival Authorization. I certify that the information on my application is true and correct, and that I have read the attached information and above rules, and all other rules and regulations herein, and understand and agree to abide by them.
